In addition to discussion about the interesting facts involved in many of the cases, the seminar provides specific instruction about how appraisers can improve certain aspects of their reports that lead to legal claims from disgruntled lenders, borrowers and other parties. We will also discuss emerging legal issues such as the FDIC, indemnification clauses and other contractual issues. I will also address liability issues that are specific to appraisers in New York, including the recent filing of approximately 35 appraiser negligence cases by an investment group named LSF6 Mercury REO Investments.
